### Funeral Preparation

The family of the deceased will meet with the presiding priest. The priest will assist the family in picking out music and readings for the funeral. If the family wishes to have a luncheon, the parish office will contact the luncheon coordinator, and the luncheon coordinator will get in contact with the family directly. All lectors must be Catholic. All music must be approved by the priest or music director.

### Funeral & Visitation Times

- Funerals start at 11am.
- Visitations:
  - Day of Funeral* - Visitations start 1 hour prior to funeral
  - Evening Prior to Funeral in Parish Center* - Visitations may be scheduled the evening prior to the funeral. The fee is \$300.00. The visitation, and facility usage, is limited to no more than 4 hours.

### Funeral Fees

- Organist - ..... \$200.00
- Vocalist - ..... \$150.00
- Church & Facility - ... \$250 (*\$400 if no Funeral Director*)
- Priest - ..... Free-Will Offering
- Luncheon - ..... Ss. Peter & Paul: Basic luncheon - *No Fee if Registered Parishioners*; any upgrades/additions charged to family (*Luncheon Coordinator will go over costs with the family*). Dobo's will bill these Funeral Homes directly: Iten's, Peterson's, David Lee, Rettinger
- St. Thomas: All food is ordered and paid for by the family through a vendor of the family's choice. The Women's Club pays for the punch, coffee, pickles, and the delivery fee for the food. The Funeral Chair coordinates bars and desserts (which are provided by parishioners).

- Cemetery Plot..... Parish Member: \$750 / Non Member: \$1,500  
(*Max 2 burials, 1 must be cremains*)
- Grave Opening/Closing..... Casket: \$800 / Urn: \$400
- Perpetual Care..... \$100.00
- Marking fee ..... \$40.00

- **St. Jeanne's** — *Make checks out to St. Jeanne de Chantal Cemetery.*
  - Cemetery Plot
    - FULL.....Parish Member: \$700 Non Member: \$1,500  
*(Max 2 burials, 1 must be cremains)*
    - CREMATION.....Parish Member: \$500 Non Member: \$1,000  
*(Single burial only)*
  - Grave Opening/Closing..... Casket: \$800 / Urn: \$400  
*Extra \$100 for winter opening/closing*
  - Perpetual Care.....\$350
  - Marking fee .....\$0 *(sexton donating time)*
  
- **St. Thomas** — *Make checks out to St. Thomas Cemetery.*
  - Cemetery Plot.....Parish Member: \$500 Non Member: \$1,000  
*(Max 2 burials, 1 must be cremains)*
  - Grave Opening/Closing..... Casket: \$500 / Urn: \$250
  - Perpetual Care .....\$0
  - Marking fee.....\$0
  
- **Old St. Thomas** — *Make checks out to Old St. Thomas Cemetery.*
  - Cemetery Plot.....Parish Member: \$500 Non Member: \$1,000  
*(Max 2 burials, 1 must be cremains)*
  - Grave Opening/Closing..... Casket: \$1,000 / Urn: \$500
  - Perpetual Care.....\$500
  - Marking fee .....\$450 – *Will be returned when stone is set.  
Gives 18 months to get stone.*
  
- **St. Patrick's** — *Make checks out to St. Patrick Cemetery.*
  - Cemetery Plot.....Parish Member: \$1,000 Non Member: \$1,000  
*(Max 2 burials, 1 must be cremains)*
  - Grave Opening/Closing.. Casket: \$1,100 / Urn: \$550
  - Perpetual Care .....\$0
  - Marking fee.....*Fee arranged with cemetery grave digger.*
